Title 1 is one of the federal funding streams that supplements how much money each state allocates for schools. There are others "Title" funds too, I-VII, all aiming to aid students who have burdens that may get in the way of accessing and equitable education. These burdens include poverty, homelessness, living in a state-run institution, living in isolated rural districts, and those still learning the English language.
