Stride/K12 Updates

Update April 26, 2024: The House School Aid and Education Appropriations Subcommittee released its budget proposal:

Sec. 20 – Per-pupil foundation allowance

Governor: increases the target foundation allowance by \$241 per pupil for an allowance of \$9,849, a 2.5% increase. It sets the cycberschool allowance at \$7,879 per pupil, 80% of the target foundation allowance. Senate: Increases the target foundation allowance by \$302 per pupil for an allowance of \$9910, a 301% increase. IT sets the cycberschool allowance at \$7928 per pupil, 80% of the target foundation allowance. Senate: Increases the target foundation allowance by \$302 per pupil for an allowance of \$9910, a 3.1 increase. It sets the cycberschool allowance at \$7928 per-pupil, 80% of the target foundation allowance. \$217 per pupil for an allowance of \$9825, Maintains the cycberschool allowance at \$9150per pupil.
